# A TREASURER



## An Interview with Helen Roper By Sheryl Peter-Kirton

When asked "Who is Helen?" she quickly responded "Difficult question!" - but true to form she was still willing to share a few thoughts and nuggets. So if you, like me, are curious about the quiet woman behind the numbers and want to learn more about her or her journey on the Council of the Barbados Tennis Association (BTA), the following paragraphs are a must read.

She is known by many as "The Accountant Lady" and to others a great partner and a loyal, caring friend. Either way, Helen Roper was excellent in her role as Treasurer - one that she held for 19 years. She is described as the "brain" and "backbone" of Council and one who has worked tirelessly "behind the scenes" to make tennis vibrant in Barbados. While there is no doubt that tennis is now her primary sport, she played lots of other sports when she was younger, mainly with bats and balls. When not on the tennis court she enjoys following all sports, gardening, walking, swimming and improving her French. Her favourite colour is blue.

Helen first joined the BTA in 2001/2, thanks to the persuasive charm of her long time friend Margot Thomson, who talked her into it. Admittedly, it was pretty confusing for her in the beginning, since she had little idea about what went on. However, taking over the treasuring from the start (from former Treasurer Paul Darrell) helped her to see what activities took place. When asked what could have been improved, she shared that better briefing of new Councillors regarding their responsibilities would have helped as would more even distribution of responsibilities across the II volunteers. That said, she also explained that this often difficult since they each had varying amounts of spare time.

As Treasurer, a typical day in the BTA life of Helen included checking the bank account online, updating cash books, paying bills, checking emails and generally following up on everything. She laughingly recalls that there was always something happening.

Not surprisingly, her favourite tennis player is Darian King (and Gael Monfils) and shared that Barbados' success in Davis Cup had definitely grown the Association. She also predicted that the recent expansion at the National Tennis Centre would do the same. Over the years she has seen the improvement in communication, especially by electronic means, but advises new members of Council to also remember more verbal follow ups in between meetings is always helpful.

While she will miss being part of a busy Association, Helen proudly also shared that she has achieved all that she hoped to over her 19 years on Council, and ENJOYED IT ALL! Now that she has hung up her "accounting boots" however she is really looking forward to following sports, gardening, walking, swimming and improving her French... MORE trips (COVID permitting)...and oh yes to Darian reaching the Top 100!!!

# 2021 YEAR-END MESSAGE FROM THE PRESIDENT



*I greet you with the peace and hope of a prosperous New Year to you and your families.* 2022 will no doubt be another challenging year.

Despite all that continues to unfold around us and affect us in the world today, particularly due to the ongoing COVID-19 pandemic and its ripple effects on our sport, let us be positive in our outlook as we navigate our daily lives to keep safe.

On November 26th, 2021, the World Health Organisation designated the B.1.1.529 variant a variant of concern to be known as Omicron. This variant has raised several concerns including increased transmissibility and the potential for vaccine escape.

To date, the Omicron variant is about two times more transmissible than the already transmissible Delta variant. It's shorter incubation period time (time from the infection to the onset of symptoms) of 2 – 3 days, means that more countries around the world are witnessing an explosion of new cases, particularly among the unvaccinated. With the higher rate of transmission, even a modest rise in hospitalization can threaten and overwhelm healthcare systems.

The evidence to date, suggests a generally milder course of illness, especially for the fully vaccinated and that a person with a history of previous COVID-19 infection is at greater risk of reinfection with Omicron. We now know that the variant can evade immunization with two vaccine doses, but immunity is likely to be restored by a third (booster) vaccine. Scientists worldwide are following this new variant closely and several countries have reinstituted strong public health measures to deal with a rapid increase in cases.

The International Tennis Federation (ITF) has encouraged the vaccination of their athletes and officials, although not stating the concept of mandatory vaccination. Nevertheless, we are all aware that vaccination certificates must be presented at ports of embarkation before boarding flights these days – indirectly stipulating mandatory vaccination.

The costs to a national Association/Federation of any of its athletes testing positive on tour can be tremendous. Not only will those athlete(s) be quarantined for an undisclosed period of time, but the Association/Federation will also have to pay for an official to stay for the duration.

Having attended the ITF's annual general meeting in early December, all participants, staff and Board Members were fully vaccinated. Repeat testing was done prior to the start of the meetings and again on Day 3 of the conference.

The Barbados Olympic Association has made their stance on mandatory vaccination of athletes and officials quite clear. I once again strongly recommend and encourage those athletes and prospective officials, who are not yet vaccinated but are thinking of representing the Association in 2022 to be vaccinated.

Let us hope for a brighter 2022 as we live through this pandemic. I trust that we are able to stage more tournaments so that our juniors are better enabled to compete regionally. May our Davis Cup and Billie Jean King Cup teams flourish next year. May those social tennis players who play for physical exercise and mental release continue to enjoy the Sport.


The total membership as at December 31 2021 increased by over 10% when compared to the prior year end from 305 to 338.



# NATIONAL TENNIS CENTRE



During 2021 grounds and court maintenance continued to be carried out at the National Tennis Centre throughout the year (including the replacement of nets and windbreakers). Force Majeure, completion of the NTC Expansion Project and the establishment of a new management structure occurred during the period under review.

Force Majeure

- The continuation of the COVID-19 Pandemic –resulted in continued restrictions on sports, no competitions, no spectators, and a reduced level of activity in the NTC Clubhouse due to protocols. Despite this the courts were actively used during the permitted periods under the curfew measures and various COVID-19 restrictions.
- The Eruption of La Soufriere Volcano in St.Vincent (April 2021) - deposited significant amounts of ash all over the island and on the court surfaces. Thanks to the assistance of volunteers and others, the BTA was able to have all of the NTC courts cleaned and restored for play within two weeks.
- The passing of Hurricane Elsa (July 2021) damaged some of the fencing on three courts and required repair. Thankfully no other damage was sustained.

## The Expansion Project

In October 2021, with the completion of the NTC Expansion Project, a key milestone was achieved in the development of tennis in Barbados. Thanks to the generous donation from the Maria Holder Memorial Trust, the NTC facility benefited from three (3) new tennis courts, an enhanced NTC Clubhouse and a dedicated and expanded car park.





The clubhouse enhancements included:

- a new Tournament Director's office,
- additional and refurbished bathrooms,
- a new storeroom,
- a new and refurbished balcony including the replacement of metal balcony rails with tempered glass,
- a refurbished bar and kitchen area,
- new guttering and tiling of floor spaces
- roof painting,



After the completion of the new courts, the BTA's online court booking system was upgraded to include all seven courts. Further, the expanded NTC facility and additional courts provided an opportunity for the BTA to expand its programmes and services. As a result of the associated and anticipated increase in activity the BTA increased its administrative resources and adopted a new management structure for the NTC.

## The New Management Structure



*Mr. Craig Smith,* served as Chairperson of the Tennis Centre Management & Operations Committee

**Mr. Damien Applewhaite** (JTI Technical Director) was also appointed as Director of Tennis, with an expanded role to include the overall management and administration of the NTC. The role of Director of Tennis is primarily responsible for managing the facility at the NTC (including its rules, policies, and physical maintenance), developing services and programmes (including rostering Coaches), and preparing regular reports to the Board of Directors on the management of the facility and its programmes.



*Miss Cherise Slocombe,* joined the BTA staff as BTA Administrator on December 8 2021 with responsibilities for the collection of payments including fees and subscriptions, office management (including office administration and supervision of daily cleaning), acting as Assistant Tennis Director at tournaments, & assisting with court scheduling.



*Mr. Julian Baird*, Head Coach and Mr. Christian Maxwell, Assistant Coach continued to be a critical part of the NTC administration (eg officiating at tournaments) in addition to steadfastly providing coaching services in the BTA programmes.

This new structure will undoubtedly improve the NTC services and efficient running of the facility and programmes.

# WHAT AFFECTED TOURNAMENTS IN 2021



The COVID-19 pandemic and the eruption of St.Vincent's La Soufriere Volcano on April 9th 2021 COVID-19 continued to affect Barbados during 2021, severely affected the BTA's ability to provide "tennis for all", with many periods when the courts were closed to the public during the first half of the year. This also negatively impacted the scheduling of local tournaments.[1]

As a result there were no locally held Junior Tennis competitions in 2021 and the National Championships were cancelled due to the pandemic and the restriction on sport during the year.

The BTA was ultimately only able to host two (2) tournaments in Barbados during 2021 and send three (3) teams to represent Barbados.


# JUNIOR TENNIS INITIATIVE PROGRAMME

IIn 2021 the Junior Development Programme (JDP) at the National Tennis Centre (NTC) continued to run under the auspices of Coach Damien Applewhaite, the inhouse programme continued to include a cadre of highly qualified and experienced team members:

- Chair Junior Development: Craig Smith
- Director of Tennis and JTI Technical Director : Damien Applewhaite
- JTI Coordinator: Andrew Thornton
- JTI Head Coach: Julian Baird
- JTI Assistant Head Coach: Christian Maxwell.
- JTI Coach: Seanon Williams

While the COVID protocols and ashfall triggered by the volcanic eruption prevented group sessions, in keeping with the guidelines, the Coaching Team offered smaller sessions for players in the Junior Development Programme.

The Programme ultimately resumed on April 26 and September 27 2021 respectively. The Coaching Team continued their training efforts for beginners, intermediates and advanced players between Monday and Friday from 3:30 – 6pm.










At the end of 2021 there were 93 players across red, orange, green and yellow ball classes, 33 of whom were female. These included 13 players in PTI and 8 in the high-performance group. Overall, the total number of players at the end of 2021 represented a 32.9% increase compared to the end of 2020.



# DAYTIME PRIMARY SCHOOLS' PROGRAMME

This programme is typically sponsored by SOL Caribbean and also receives contributions through the SOL & RBC employees donor programme. It primarily involved three neighbouring schools - Blackman and Gollop, Grantley Prescod and Luther Thorne. More recently sponsorship from Megapower provided opportunities for students of School House for Special Needs to have fun with tennis.

Unfortunately it could not be held in 2021 due to the pandemic and the restriction on sport during the year.

# <sup>ΤΟΡ 8</sup>

Darian King and Gabrielle Leslie were the two male and female of the Top 8 Invitational event, the BTA's open tennis showpiece to end the year in December 2021 and, to the delight of the tennis fraternity the event was held with spectators. Up to 8 of our top men and women compete in a round robin event, followed by a semi-final and final round. If necessary, a qualifying round is also held.

Building on the response from 2020, the Top 8 tournament was once again open to a wider field of interested competitions and started with the Top 8 Qualifying Round.

The event began with an eighteen (18) man Qualifying draw which saw Seanon Williams and Nicholas Charles qualify for the main draw, earning their spots to play alongside Darian King, (1) Matthew Foster-Estwick, (2) Kaipo Marshall, (3) Xavier Lawrence, (4) Russell Moseley & (5) Stephen Slocombe.

The favourite Darian King won, defeating Matthew in the final, all without dropping a set during the event!

In the women's' category, the pool was notably smaller with six competitors - Gabrielle Leslie, (6) Hannah Chambers, (7) Serena Bryan, (8) Taisha Jones, (9) Shonte Sargeant and (10) Simone Bannister.

In the final Gabrielle Leslie won her third consecutive Top 8 event, defeating fellow Fed Cup squad member Hannah Chambers 6-2,6-3.

# NATIONAL RANKINGS

# D A V I S C U P WORLD G R O U P II 16-17 SEPTEMBER 2021

Following our loss to Indonesia in the 2020 World Group I Play-off tie in March 2020, Barbados was drawn to play Indonesia at home. This World Group II tie was played on September 16 -17 2021, after the event was postponed from September 2020.

The team of Darian King, Haydn Lewis, Matthew Foster-Estwick, Kaipo Marshall and junior Stephen Slocombe with non-playing captain Damien Applewhaite represented Barbados.







In keeping with the Government directives, the BTA obtained the permission of the COVID unit to hold a competitive sporting event however no spectators were allowed into the venue due to Covid-19 protocols. The media was not allowed face to face access to the teams, and post-match press conferences were held via Zoom.

Barbados secured a 3-1 victory with Darian King winning both his singles matches with loss of only 8 games, as well as the crucial doubles tie with Haydn Lewis 6-1,7-6. Barbados remained in World Group II and played its next tie away in Turkey against Ukraine.

in March 2022. Kaipo Marshall played the other 2021 singles tie.

Under the sponsorship of Ratuken the ITF pays nations' participation fees based on Groups, for competing in the competition. As recommended by the ITF, the Association has therefore been able to set aside funds for special development projects including squad training, player development initiatives, administration and facilities improvement, plus funding for future home Davis Cup ties, and officiating courses.

Their tie was played in La Paz, Bolivia and they were drawn in Pool A alongside home nation Bolivia, Honduras and Puerto Rico. The Barbados team experienced issues with the altitude and were unable to get any victories, and did not advance from the pool stage.

# LOCAL & OVERSEAS JUNIOR TOURNAMENTS EVENTS & ACHIEVEMENTS

# LOCAL TOURNAMENTS

Sadly, as a result of the pandemic there were no locally held Junior Tennis competitions in 2021. Pre-Covid the BTA usually sanctioned eight junior tournaments a year. Four of these sanctioned tournaments were held at the National Tennis Centre and four at Ocean View Tennis Club. Post pandemic the Committee is revisiting the annual junior tournament calendar in light of the expanded NTC facility.

# JUNIOR NATIONALS 2021

Due to the pandemic and the restriction on sport in 2021 the National Championships were cancelled.

# WORLD JUNIOR CHAMPIONSHIPS (U14) 2021, JUNIOR DAVIS CUP AND JUNIOR FED CUP 2021

Regrettably these events usually held in February and March each year were cancelled.

# BARBADOS INTERNATIONAL JUNIOR TENNIS TOURNAMENT 2021 – U18 & U14

This Tournament, hosted by the BTA, is a prestigious event and provides our players with an opportunity to complete at a higher level at home. It was cancelled in 2021. The tournament is usually held over Easter week and is sanctioned by the ITF as a Grade 4 event on the ITF U18 Junior Circuit and a Grade 2 in the COTECC U14 circuit.

The Barbados Cup scheduled for November 2021 was regrettably also cancelled. It up to 2019 was a Grade 5 ITF junior event which had been hosted for three years under the direction of Mr. Karl Hale of Canada.

# JITIC U14 & U18 2021

JITIC U14 is the premier regional tournament on the COTECC calendar and was scheduled to be played in the summer of 2021.

The U18 JITIC is a closed event (to COTECC players only) an ITF Grade I tournament, which allows players to enter based on the U18 ITF rankings.

In 2021 only Hannah Chamber was fortunate enough to compete in the U18 JITIC.



# 12&U ITF/GSDF COTECC TEAM COMPETITION

Fortunately, the 12&U ITF Grand Slam Development Fund team championship was held at the end of summer 2021 and Barbados sent a team. The event was organized in a bubble with players and officials only and under strict COVID protocols.

A boys teams attended the Competition which was held in the Dominican Republic, from September 25 to October 2, 2021. It was a combined event of Sub Regions 3 & 4 and ten boys and six girls teams participated.

Boys Team Damien Applewhaite (Captain) Dimitri Kirton Ethan Warner Travis Licorish

The Barbados boys team defeated USVI and Haiti & were level at 1-all with Trinidad when their scheduled flight required them to forfeit the all-important doubles, therefore placing 6th out of 10 teams. A very commendable result for a relatively young team.

# JUNIOR ACHIEVEMENTS (AND REPRESENTATION AT THE JUNIOR PANAM GAMES) 2021

Hannah Chambers start 2021 ranked #334 on ITF U18 world rankings. She was classified as an "Emerging Athlete" by the Barbados Olympic Association and received assistance to continue her ITF U18 competition schedule, despite the pandemic. Hannah was able to play a number of J4 & J5 regional events. These were typically backto-back tournaments in Costa Rica (January), Mexico\El Salvador (May\June), Mexico (July), Dom Rep (August & October). These were ideal preparation for the Junior PanAm Games.

In May 2021, Hannah Chambers was also selected, to participate in a three-week tour in the Regional 17&U ITF/COTECC Team to three J3 tournaments in Mexico. This project was financed by the GSDF and administered by COTECC. She was afforded this opportunity because she was one of the highest ranked 17-year-old U18 players from the COTECC region. There was strong competition in these tournaments, even the J4 & J5 tournaments which included highly ranked competitors (who were keen to return to competition) and Hannah ended 2021 ranked #618.

In 2021 two of our top ranked juniors on the ITF Junior circuit Hannah Chambers and Stephen Slocombe were selected to represent Barbados at the inaugural Junior Pan American Games that were held in Cali, Colombia, from November 25 to December 5, 2021. There were accompanied by Andrew Thornton as Captain and were a part of the Barbados Olympic Associations contingent of 14 athlete and 12 officials.

Stephen's preparation included ITF tournaments in Mexico & El Salvador in May\June 2021 as well as a stint at an academy in Florida in August.

# ATP PROFESSIONAL DARIAN KING

Following a restricted 2020 competitive season due to COVID and wrist surgery, Darian was able to enjoy a more intense schedule as the Pro circuit opened up again in 2021.

Throughout the year, Darian competed in several ITF and ATP events primarily across the USA with some success. The highlight of the year was his 3 set victory against American Maxime Cressy, then ranked #151 at the Lexington Challenger event in July, before losing against#181 ranked American Ernesto Escobedo in the quarter finals. Cressy has since risen to a recent career high of #31 having won several ATP 250 events across the world during 2022.

Darian also played his part in Davis Cup action leading Barbados to victory in the rescheduled 2020 Group 2 round 1 tie played at home in September 2021 against Indonesia. Darian won his two singles and together with partner Haydn Lewis also won the doubles without losing a set during the tie.

At the end of 2021, Darian's ATP singles ranking was #383 and his doubles ranking #541.

# AFFILIATIONS

## National Sports Council (NSC)

The Association received a subvention for the period 2019/2021 plus elite athlete Darian King also received funding from the NSC during 2021.

#### **Barbados Olympic Association (BOA)**

The BOA supported the Association with grants towards administration, ITF membership fees and representation at international and regional Annual General Meetings. In addition, funding was provided towards local and overseas competitions and the assistance for Hannah Chambers and Darian King continued during the year.

#### **International Tennis Federation (ITF)**

Grants were received from the ITF in respect of Davis Cup and JTI Development, and towards travel expenses for junior teams.

#### Arts and Sports Promotion Fund (ASPF)

No applications were made to the ASPF during 2021.


#### Sponsors

# NEW INITIATIVES

### Adult Tennis Initiative

## <u>Social Tennis</u>

Many a Thursday night a junior player or two could be seen trying their luck against the more seasoned tennis crew present at Social Tennis. This private initiative was launched in October 2021 and was the place to be for the tennis savvy. Every Thursday from 6 – 8 pm, 12 to 15 players competed for bragging rights. Demand was high and interested parties needed to book early to be assured a spot. Interested parties were encouraged to contact the Director of Tennis.

## <u>Gift Certificates</u>

The BTA also launched its first Gift Certificate Packages in December 2021, encouraging interested parties to give the gift of tennis, gifting court time, or sessions for those wishing to learn how to play tennis.

# AN IMPORTANT NOTICE FROM THE BTA

For a long-time, the Barbados Tennis Association Inc. (BTA) had a dream of expanding the facilities of the National Tennis Centre (NTC). We appreciate that such an increase in the natural resources of the BTA could further facilitate the positive growth and development of tennis in Barbados at all levels. It was envisioned that the expansion would translate into further developing our young players to world ranking, strengthen our membership, increase promotion of our programmes and activities, open the door for greater participation in regional and international tennis, and by extension, enhance the image of tennis in Barbados and the Association overall.

The Maria Holder Memorial Trust has helped to make our collective dreams come true. Thanks to their very generous donation, we now have three (3) additional courts, a new hitting wall, and a newly uplifted Club House nestled within a more secure and visually appealing tennis plant. However, the COVID-19 pandemic and the resulting protocols and global shut-downs continue to severely limit our ability to meet face-to-face, host fundraising activities, host or participate in local and international tennis tournaments or send our junior players overseas.Furthermore, our social tennis environment at the NTC has also been affected. While there is no doubt that the last twenty-one (21) months have been a challenge for our members and tennis as a whole, seeing the new physical plant has revitalised all of us.

Indeed, we have resolved to be even more strategic in how these resources are used to ensure a) the BTA's financial sustainability and b) re-establish the family culture of the NTC. As a member, your role is essential to our achievement of these goals as we rely heavily on your membership, support and participation, donations and sponsorship, and your ongoing use of the courts at the NTC.

## More Strategic Use of Resources

## The Facility

A recent review of the finances has revealed that our membership subscription and court rental fees have been steady for over ten (10) years without an increase, despite the constantly rising cost of maintaining the facility, particularly the grounds and courts. However, taking into consideration the further increased maintenance, utility and insurance costs associated with the expanded plant, as well as the negative and protracted impact of the pandemic, we are forced to face the harsh reality that we can no longer absorb the increases without affecting the viability of the BTA. As a result, effective January 1, 2022, membership subscriptions and the per-hour court rentals fees will be increased marginally. Please see Appendix 1 for details on the same.

## The Staff

A new management structure is in place at the NTC to assist the Executive Council with the efficient running of the facility and programmes. The following team is therefore responsible for the day-to-day management of the NTC.

1. Mr. Damien Applewhaite will serve as the interim Director of Tennis. This role is primarily responsible for managing the facility at the NTC (including its rules, policies, and physical maintenance), developing services and programmes (including rostering Coaches), and preparing regular reports to the Executive Council on the management of the facility and its programmes.

2. Ms. Cherise Slocombe will serve as Administrator, effective December 8, 2021.The Administrator is responsible for the collection of payments including fees and subscriptions, office management (including office administration and supervision of daily cleaning), acting as Assistant Tennis Director at tournaments, & assisting with court scheduling.

3. Mr. Julian Baird and Mr. Christian Maxwell will continue to steadfastly provide coaching services to the junior players of the Junior Tennis Initiative (JTI) programme, and to other persons interested in learning to play tennis. We are confident that this new structure will help us improve our services to you, our valued members.

## New Streams of Income

As part of the new efforts to raise funds, the BTA will soon be renting billboard space at the facility. Rates will be offered as 1-year contracts or 2+ year contracts, with additional opportunities for benches around the grounds to be sponsored.
