BARBADOS TENNIS ASSOCIATION - MEMBERSHIP: All Juniors must be financial members of the Barbados Tennis Association to take part in this tournament. New members must submit membership applications, subs and entry fees at the time of entering the tournament so that your entry may be processed before the start of the tournament.

TIMES OF PLAY: Play starts at 3.30 pm on the first three days and at 8.00 am on the following days.
 Players who have matches scheduled on the first day will be informed by phone if they put a phone number on their entry form. Thereafter Players must either contact the Tournament Director at the National Tennis Centre or check the schedule daily for their next scheduled match. Those entering more than one event must be available to play throughout the period of the tournament. Previously scheduled appointments must be submitted on the back of the entry form.
The 15 minute default rule will be strictly enforced.

RANKING: This tournament will be an official Barbados Tennis Association ranking tournament.

BALL BOYS & UMPIRES: All Players will be expected to assist with ball-boying and umpiring and should check with the Tournament Director after completing their match to see if they are required to assist.
